Conditions of Entry: Conditions of Entry: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Singles Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified.

Eligibility Only purebred Italian Greyhounds that are at least one year of age may enter and must be individually registered with the appropriate registry. (i) "All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)"

Ribbons or rosettes will be offered for all placements. First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold

REGULAR STAKES OFFERED:

OPEN - Any eligible Italian Greyhound, excluding ASFA Field Champions of record that has met ASFA certification requirements.

FIELD CHAMPION - Any ASFA Field Champion.

<u>VETERAN</u> - Any eligible Italian Greyhound which is 6 years or older on the day of the trial and has met ASFA certification requirements. Points go toward V-FCh and V-LCM titles.

SINGLES STAKE: Any eligible Italian Greyhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Italian Greyhounds are eligible to earn TCP and CPX titles from the Singles stake.

BEST IN FIELD WILL NOT BE OFFERRED.

Equipment: We will use battery powered DRAG lure machines will be used, with backup equipment on site. Lure will be white and/or black plastic bags.

Field: The field is open pasture and is fenced from the road, with natural tree and water barriers on the three other sides.

General Information

- IGCA recommends that your hounds be in good physical condition before attempting the course.
- Bring shade for your dogs Water and Portable toilet on site.
- Pick up after your dog and yourself.
- Entries only accepted when payment is also received. Entries that are illegible will be refused.
- IGCA strongly recommends emailing/PayPal entries with the recent unreliability in the US Postal Service.
- Please include a phone number on your entries in case of bad weather.

- No open fires allowed (small, contained, propane fire pits are permitted)! If you
 must smoke or vape, please do so inside of your vehicle. Conditions are quite
 dry and even an errant cigarette ash could spark a fire.
- Weather in Washington is unpredictable from very warm temperatures to rain – bring rain gear, layers of clothing, hat, gloves, sunglasses, and sunscreen.
- Some first aid supplies will be available at the field; however, you are advised to bring your own first aid kit for you AND your dog.
- A \$25 fee will be assessed for any returned checks.
- We will have an earlier roll call and inspection for hounds for the field trial committee, working IGCA members, lure operators, and judges.
- NO flexi leads are allowed on the grounds.
- Cooling pools will be on site for before and after runs.
- A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.
- A penalty of \$5.00 will be assessed for any waste material left on the grounds by a dog or person. This also includes trash. Waste and trash disposal equipment and containers will be available.

ASFA Certification runs will be held before the trial. Limit of 6 Italian Greyhounds. Open to all eligible Italian Greyhounds at least 11 months of age. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course. Hounds completing Certifications at this event may then enter the Trial at Early Entry rates.
