Late, incomplete, conditional, unsigned, unpaid entries and entries without a registration number will NOT be accepted. Entries will NOT be acknowledged by mail. Substitutes for lame or in-season hounds will be allowed if substitute has the same owner and the trial secretary is notified before the close of day-of-trial entries.

Rosettes will be offered by ASFA for: All placements, Ribbons –1st, blue; 2nd, red; 3rd, yellow; 4th, white; NBQ, green; High Scoring Single, navy and gold: BOB, purple & gold rosette and medallion: Best In Regional, red, white and blue: Bench, light green: Kennel and Breeder, pink and light green: .

Trophies will be offered by LARK for: All placements, High scoring single, BOB winners, Best in Regional, Kennel, Breeder and Bench stakes. .

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Any hound that has earned at least one ASFA point is eligible to enter. For a Provisional breed to be eligible, the entered hound must have received a placement, with competition. All points or placements must be earned by the closing date of the event. Any hound entered in the Singles Stake does not need prior ASFA experience. An eligible hound may be entered in any number of Regional Invitationals

Regular Stakes Offered

OPEN STAKE: Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record. A photocopy of the hound's registration must be submitted at the hound's first trial. This is waived for NGA greyhounds

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years and that have met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

PROVISIONAL: Any eligible hound of a Provisional breed that has met certification requirements. Not eligible for Best In Field.

SINGLES STAKE: Any eligible sighthound including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes, are eligible to enter. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Provisional Breeds are not eligible for these titles. Not eligible for Best of Breed or Best In Field.

Non—Regular Stakes Offered

BREEDER STAKE: An entry shall consist of two hounds bred or co-bred by the same individual. Hounds must be entered in one of the regular stakes (Open, FCH, or Veteran) Scores of the two hounds will be added and the highest combined score will be awarded the Breeder Stake Award.

KENNEL STAKE: An entry shall consist of two hounds owned by and living with the same person. Hounds must be entered in one of the regular stakes (Open, FCh, Veteran). Scores of the two hounds will be added and the highest combined score will be awarded the Kennel Stake Award.

FOR BREEDER AND KENNEL STAKES: Entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake. Hounds are named at the time of entry by completing the attached form. Singles are treated as a "breed" unto themselves, therefore both dogs must be entered in singles to be in Breeder or Kennel Stake.

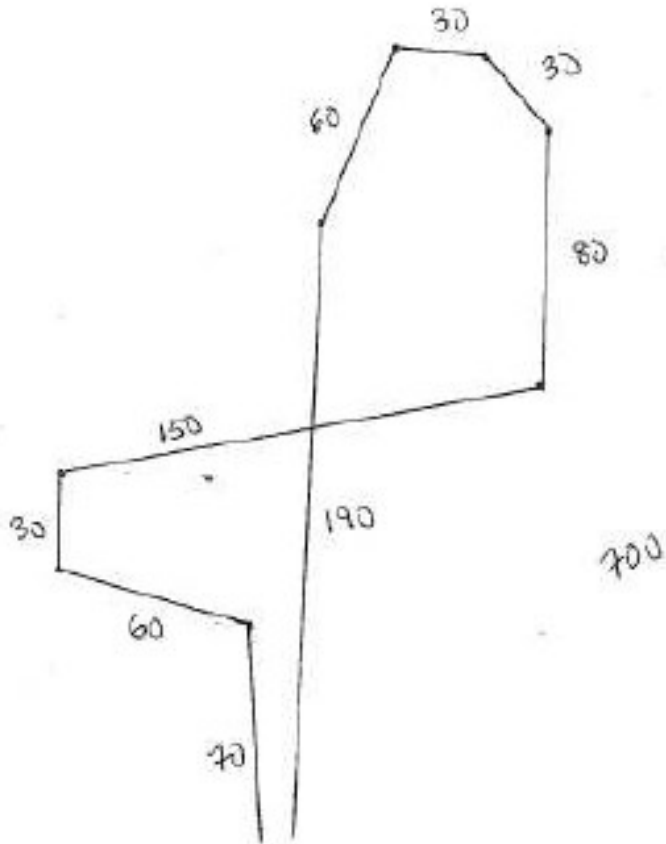
Bench Stake: For any hound eligible to enter a regular stake, that is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each Stake entry.

BEST IN REGIONAL will be offered. .

Conditions of Entry: All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.

The Brynmair Trophy, donated by the hounds of Brynmair, is in honor of the coursing Irish Wolfhounds past and present and to encourage the continued participation of those hounds who love the sport of lure coursing.

Rhodesian Ridgeback — The Old Goat Trophy

Donated in loving memory of Eve, Ch Windriver's Crimson Arrow CD LCM CGC ROM VC. The foundation of Rare Earth Ridgebacks, Eve's claim to fame is more for her descendants than from her own coursing career, which didn't start until she was six years old. Eve earned her LCM at the age of ten and was still used as test dog at fourteen. Eve's descendants include five #1 RRs: Phoebe, Maggie Mae, Ida, Wanda and Nitro, as well as seven Lifetime Top Twenty RRs: Ida, Star, Zappa, Troi, Wanda and Nitro. Saluki — The Saluki Trophy

Donated by Tom Cigolle Jr. in loving memory of BIT Montebello Sherom's Fuhais LCM6. Fuhais' wish was to make sure that the Salukis of today and tomorrow are always honored and remembered. Her passion for the chase is the legacy she leaves to us all.

Whippet — The Bevis Trophy

The Bevis Trophy was originally called The S.L.O. Trophy to commemorate the relationship between Sharon Louise Othick and Bill Othick's Whippet "Spy".
