Registration

All dogs entered in LCI stake must have a registration number. If your dog is registered under any of options A - E below, then you must attach a copy (not the original) of the registration certificate to your dog's first ASFA trial entry form. If your dog is not registered under any of the options A - E below, then you may obtain a registration number under paragraph F below.

- A. A registration from AKC or CKC as one of their recognized breeds, or
- B. A registration from AKC Canine Partners or CKC (CCN) as a mixedbreed or other ineligible dog for registration under A (above), or
- C. A registration from AKC PAL (Purebred Alternative Listing), as a pure breed dog ineligible for registration under A (above), or
- D. An FSS (Foundation Stock Service) breed, as a member of a breed that is in the process of obtaining full AKC recognition, or
- E. A registration from UKC (United Kennel Club), which is an international dog registry that focuses on performance, or
- F. If your dog has no registration, you can register your dog with ASFA at the time your dog enters his/her first trial as follows:
 - Complete the registration form below
 - Attach a onetime registration fee of \$10, payable to ASFA
 - Submit the registration form and fee to the Field Trial Secretary along with for your dog's first ASFA trial entry form.

The Field Trial Secretary will submit the registration form and fee to ASFA along with the trial records. Please retain a copy for your records until you receive a permanent registration number from ASFA.

Conditions of Entry

- Dogs must be one year of age or older on day of trial.
- Females in season, lame dogs and those that are unfit to course will be excused at roll call.
- Dogs absent at the time of roll call will be scratched.
- All dogs will be run twice unless excused, dismissed or disqualified.
- All dogs will run alone.

Stakes Offered

All dogs entered are competing for the title of Lure Coursing Champion (LCC)

Small - Dogs 17.5" or less at the withers and for all brachycephalic (flat faced) dogs

<u>Small Open Stake</u> – for Small dogs that have not achieved the title of LCC <u>Small Senior Stake</u> – for Small dogs that have achieved the title of LCC. <u>Small Veteran Stake</u> – for Small dogs that are over the age of 7.

Large - Dogs over 17.5" at the withers

<u>Large Open Stake</u> – for Large dogs that have not achieved the title of LCC <u>Large Senior Stake</u> – for Large dogs that have achieved the title of LCC. <u>Large Veteran Stake</u> – for Large dogs that are over the age of 7.

Sighthound Mix - Dogs with sighthound breed in its background

<u>Sighthound Mix Open Stake</u> – for Sighthound Mix dogs that have not achieved the title of LCC

<u>Sighthound Mix Senior Stake</u> – for Sighthound Mix dogs that have achieved the title of LCC.

<u>Sighthound Mix Veteran Stake</u> – for Sighthound Mix dogs that are over the age of 7.

Other Information

- Battery powered continuous loop lure machine will be used. Backup equipment will be available.
- Lure will consist of highly visible plastic strips.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- There will be a \$5.00 fine assessed for any loose hound not participating in the course.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
- The field is not fenced, but is well away from the entrance to the facility.
- Children must be under control of their parents or guardians at all times.

Course Plan

The course will be reversed for the finals. ASFA reserves the right to alter the course plan as required by weather and/or field conditions on the date of the trial.

Field Conditions

The fields are well-groomed grassy fields that used by model airplane enthusiasts from with to fly their planes. The area is very expansive and there are no obvious sight lines on any of the three fields being used for the II. Exhibitors should make sure that their dogs are in good condition when running on these fields; the courses are long and there is topography.

Individuals entering and using the AMA facilities and/or grounds do so at their own risk. The AMA shall not be liable for any claims for bodily injury to themselves or their dogs or property damage arising out of or related to the use of the International Aeromodeling Center.

Directions to the field

From the East on I-70: Take exit 149 B, Route 35 North. Go 33 miles to Route 67. Right (north) onto 67 (Muncie bypass). In less than 2 miles take the Memorial Drive Exit. See below from Memorial Drive exit.

From the West: Take I 465 around Indianapolis to I 69 North towards Fort Wayne. Take Exit #34, Route 67 - Muncie bypass. Go about 14 miles to exit for Memorial Drive. See below from Memorial Drive exit.

From the North on I 69: Take exit #332, East McGalliard Road. Go through Muncie business district to Route 67 South (Muncie bypass) Take exit for Memorial Drive. See below from Memorial Drive exit.

From Memorial Drive Exit: From north or south turn left onto Memorial Drive. In about half (1/2) mile, the AMA sign will be on your right. Turn right into grounds at the sign. Continue past the buildings keeping on Aeromodeler's Blvd to first road to the right, McLaughlin Road. Turn right onto McLaughlin Road. At next inter-section turn Left on Center Road. Parking area will be on your left before the cemetery. There will be signs.
