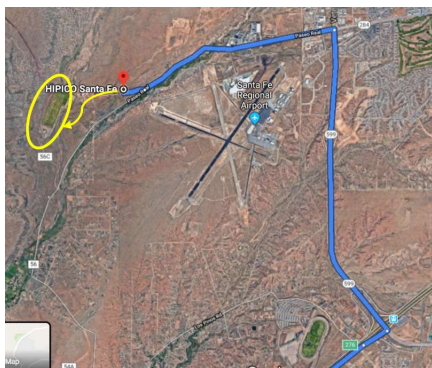

## ENTRY FEES AND INFORMATION:

**EARLY ENTRIES:** \$25 first dog/entry/day, \$15 additional dogs from same owner, same day. Certification runs (Saturday only) \$10. **DAY OF TRIAL ENTRY FEES:** \$30/entry, no multi-dog discount. **Day of trial entries close at 8:00 am at the FTS's desk.**

Make checks payable to LLCC or send entry funds via PayPal to [FTSLLCC@gmail.com](mailto:FTSLLCC@gmail.com). If using PayPal, please either send as "Friends and Family" or add \$2.00 per transaction. Include dog name(s), day(s) entered, and stakes entered.

**Online entries will be accepted by emailing directly to the Field Trial Secretary:** email signed entry forms to [Cynthia.sisson@gmail.com](mailto:Cynthia.sisson@gmail.com) along with proof of payment via PayPal. **Entries WILL be acknowledged by email.** If you do not hear back from the FTS within 48 hours, please check the email address you sent the entry to and re-send.

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call.

Property owners and LLCC or its members are not responsible for any accidents or injury at these trials.

**TRIAL HOURS:** From 7:30 AM until after ribbons are awarded

**ROLL CALL promptly at 8:30 AM. DRAW 9:00 AM**

Any hound not present at Roll Call will be scratched and entry fee will not be refunded.

**ONLY FIVE CERTIFICATION RUNS ARE AVAILABLE PRIOR TO THE TRIAL.** Owners are responsible for supplying a dog of similar running style. **If you want to certify your dog and run in the trial, send in entries for a Certification run (\$10) along with an entry in Singles.** If your dog passes the Certification run, it can be moved to the appropriate Open or Veterans Stake.

Early inspection of hounds for members of the field committee may begin one-half hour prior to published hours.

### **ELIGIBLE BREEDS & REGISTRY FOR THE TRIALS**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP/PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### **REGULAR STAKES OFFERED**

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion.

**VETERAN STAKE:** Any eligible hound whose age is at least six years and has met certification requirements, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

### **LCI STAKES OFFERED**

LURE CHASING INSTINCT (LCI) Stake: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**LCI Entries:** Check **TWO** boxes on the LCI entry form, one for Small / Large / Sighthound Mix and one for Open / Excellent / Veteran.

### **LCI STAKES OFFERED**

LURE CHASING INSTINCT (LCI) Stake: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**SMALL OPEN:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**SMALL EXCELLENT:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**SMALL VETERAN:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**LARGE OPEN:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**LARGE EXCELLENT:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**LARGE VETERAN:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**SIGHTHOUND MIX OPEN:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**SIGHTHOUND MIX EXCELLENT:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**SIGHTHOUND MIX VETERAN:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length

## CONDITIONS OF ENTRY:

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Hounds with breed disqualifications are not eligible to enter except in the Singles Stake and LCI Stake.
- ⇒ Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed, or disqualified.
- ⇒ LLCC and property owners assume no liability for any accident or injury to any person or dog before, during or after these trials.
- ⇒ All animals on trial grounds need to be current on vaccinations as required by New Mexico State Law.
- ⇒ A \$5 fine will be assessed for any hound loose on the field other than those running the course in progress.
- ⇒ **Note all dogs – including Singles and LCI entries – must wear blankets during their course. Some loaner blankets will be available.**
- ⇒ **PICK UP AFTER YOUR DOGS AND YOURSELF!**
- ⇒ **\$25 fine for returned checks.**
- ⇒ **As always, NO POOP BAGS IN THE PORT-A-POTTY!**

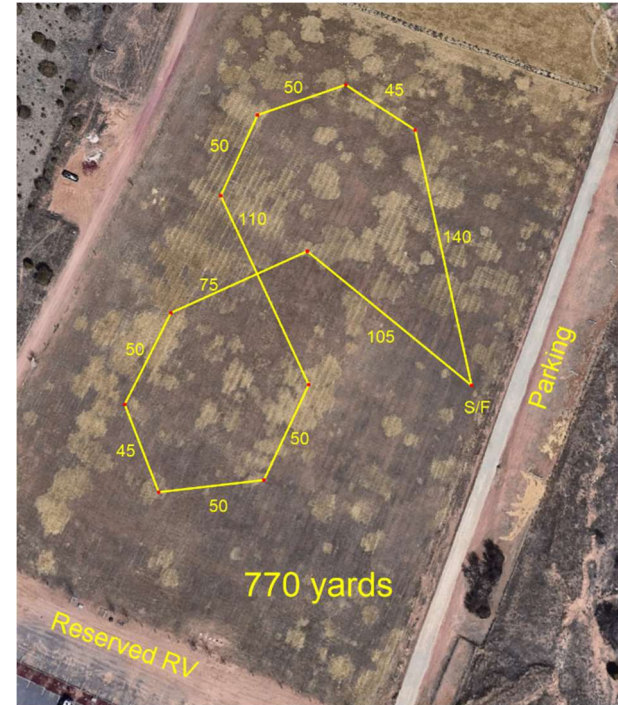
**EQUIPMENT AND COURSE PLANS:** Type of lure machine: battery-powered continuous-loop system. Continuous loop equipment will be used. Lure will consist of highly visible white and/or black plastic. Back-up equipment will be available. The elevation is ~6,200'. Courses will be reversed for finals, runoffs, and Best in Field. LLCC reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial.

## SUNDAY **770 yards**



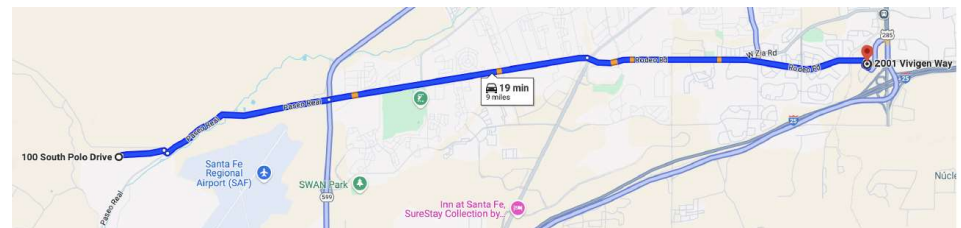
