Driving Directions to Peterson Pivot Field, Estancia, NM

County Road A025 / La Trencaieriea Road

Note: this is an agricultural field and does not have a street address. County Road A025 / La Trencaieriea Road extends for half a mile in Torrance County and dead ends at the gate to the Peterson Pivot Field. GPS directions can be set to the road name (try both).

From the north / Santa Fe: Take I-25 Exit 290 and head south on US-285 for ~6.5 miles. Turn right onto Highway 41 and follow it for 51 miles to Estancia. From Estancia, continue 6 miles south on Hwy 41 to NM-542. Turn right / west on 542.

From the east or west via I-40: take Moriarty Exit 196 (Highway 41) and go south 17 miles to Estancia. From Estancia, continue 6 miles south on Hwy 41 to NM-542. Turn right / west on 542

From the south / Mountainair: Take US 60 east 12 miles. Turn north onto Highway 41 and continue 4.5 miles to NM-542. Turn left / west on 542.

Follow 542 for 2 miles, past the greenhouses, to County Road A025 / La Trencaieriea Road. Turn right and proceed 0.5 miles through the gate. Turn right to follow the southern border of the pivot, to the alfalfa where the course is set. **MAX SPEED 15 mph on dirt roads!**



There will be a port-a-potty on-site.

ENTRY FEES AND INFORMATION:

EARLY ENTRIES: \$25 first dog/entry/day, \$15 additional dogs from same owner, same day. Certification runs (Saturday only) \$10. **DAY OF TRIAL ENTRY FEES:** \$30/entry, no multi-dog discount. **Day of trial entries close at 8:00 am.**

Make checks payable to LLCC or send entry funds via PayPal to FTSLLCC@gmail.com. If using PayPal, please either send as "Friends and Family" or add \$2.00 per transaction. Include dog name(s), day(s) entered, and stakes entered.

Online entries will be accepted by emailing directly to the Field Trial Secretary: email signed entry forms to Cynthia.sisson@gmail.com along with proof of payment via PayPal. You should receive an acknowledgement within 24 hours.

Entries WILL be acknowledged by email. If you do not hear back from the FTS within 48 hours, please check the email address you sent the entry to and re-send.

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. Property owners and the LLCC, or its members are not responsible for any accidents or injury at these trials.

TRIAL HOURS: From 7:30 AM until after ribbons are awarded

CERTIFICATION (SATURDAY ONLY) ROLL CALL promptly at 8:00 AM. ONLY FIVE CERTIFICATION RUNS ARE AVAILABLE. Owners are responsible for supplying a dog of similar running style. **If you want to certify your dog and run in the trial, send in entries for a Certification run (\$10) along with entries in Singles.** If your dog passes the Certification run, it can be moved to the appropriate Open or Veterans Stake.

TRIAL ROLL CALL:

SATURDAY 8:30 AM or 10 minutes after the final Cert run, whichever is later. SUNDAY 8:30 AM.

Early inspection of hounds for members of the field committee may begin one-half hour prior to published test hours.

RIBBONS:

ELIGIBLE BREEDS & REGISTRY FOR THE TRIALS

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion.

VETERAN STAKE: Any eligible hound whose age is at least six years and has met certification requirements, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SUNDAY REGIONAL INVITATIONAL ELIGIBILITY

Any hound that is ASFA pointed or is pointed in its country of residence or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Provisional Stake. All points or placements must be earned by the closing date of the event. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

A dog earning one or more points in the Saturday 11/11 trial may be GATE ENTERED for Sunday. Please be kind to your Field Trial Secretary and submit your entries as early as possible (Saturday after the trial) rather than waiting until right before the Sunday morning deadline!

NON-REGULAR STAKES OFFERED (Sunday only)

Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes at a Regional Invitational.

KENNEL STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person.

BREEDER STAKE: For any breed which shall have, designated at time of entry, two hounds bred by the same individual.

BENCH STAKE: For any eligible sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC.

LURE CHASING INSTINCT STAKES OFFERED SATURDAY ONLY

The Lure Chasing Instinct Program is open to NON Sighthounds and Sighthound mixes. All dogs entered must have a registration number with the AKC (including Canine Partners, PAL, and FSS programs), UKC, CKC, OR ELSE be registered with ASFA at the time of his/her first trial (registration form included in this Premium List).

LCI Entries: Check **TWO** boxes on the LCI entry form, one for Small / Large / Sighthound Mix and one for Open / Senior / Veteran.

Small Open: dogs 17-1/2" or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC. **Small Senior:** dogs 17-1/2" or less at the withers and/or brachycephalic dogs who have achieved an LCC. **Small Veteran:** dogs 17-1/2" or less at the withers and/or brachycephalic dogs over 7 years.

Large Open: dogs over 17-1/2" at the withers who have not achieved the title of LCC. **Large Senior:** dogs over 17-1/2" at the withers who have achieved the title of LCC. **Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound mix Open: dogs with a sighthound breed in its background who have not achieved the title of LCC. **Sighthound mix Senior:** dogs with a sighthound breed in its background who have achieved the title of LCC. **Sighthound mix Veteran:** dogs with a sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

CONDITIONS OF ENTRY:

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Hounds with breed disqualifications are not eligible to enter except in the Single Stake and LCI Stake.
- ⇒ Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
- ⇒ LLCC and property owners assume no liability for any accident or injury to any person or dog before, during or after these trials.
- ⇒ All animals on trial grounds need to be current on vaccinations as required by New Mexico State Law.
- ⇒ A \$5 fine will be assessed for any hound loose on the field other than those running the course in progress.
- ⇒ Clean up after yourself and your dogs!
- ⇒ **\$25 fine for returned checks.**
- ⇒ **As always, NO POOP BAGS IN THE PORT-A-POTTY!**


Bring your own Water and Shade.

LLCC reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial.


