Rosettes and Medallions

Rosettes will be offered by ASFA for all placements, 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), High Scoring Single (navy/gold), Best of Breed (purple/gold), & Best in Regional (red/white/blue). Medallions will be offered by ASFA for Best of Breed. Rosettes (pink/green) will be offered by ASFA for the winners of the non-regular stakes. Prizes will be offered by MGA and friends of MGA for all placements.

Trial Hours: 7:00 A.M. until one hour after the last scored course of the day

Roll Call: 7:30 A.M. Substitutions will be accepted for lame or in-season hounds. Roll Call may start a half hour early.

Make checks payable to "MGA" in US funds. Do NOT send entries "signature required". Entries will NOT be acknowledged by mail. Late, incomplete, or unpaid entries will not be accepted. Entries maybe acknowledged by e-mail if a legible e-mail address is provided on the entry form. There will be a \$25 fee for any returned check.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets. Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign, ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Gas powered continuous loop lure machines will be used, with backup equipment on site
The lure will consist of highly visible white or black plastic strips ● Course may be altered as required by weather or field conditions ● Course will be reversed for finals ● A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.

Regional Invitational Requirements: Any hound that has at least one ASFA point, is pointed in its country of residence, or is AKC pointed is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned prior to the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes

STAKES OFFERED

OPEN STAKE: Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone.

Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

KENNEL STAKE: For any individual breed, two hounds designated at time of entry that are owned and kenneled by the same person. Single Stake entries not eligible.

BREEDER STAKE: For any individual breed, two hounds designated at time of entry that are bred by the same individual.

BENCH STAKE: For any individual breed, an individual hound with proof on file with ASFA of a conformation champion title from the AKC, CKC, or both, or a conformation grand champion title from the UKC. Single Stake entries not eligible.

Best In Regional will be offered.

Lure Chasing Instinct (LCI) Stakes Limited to 10 dogs

Eligibility: Any dog that has at least one ASFA point is eligible to enter the LCI Regional Invitational.

Open to non-sighthound and sighthound mixes. All entries must be individually registered with the AKC (including ILP and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

SMALL OPEN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic ("flat-faced") dogs that have not achieved the title of LCC.

SMALL EXCELLENT STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that have achieved the title of LCC.

SMALL VETERAN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that are over the age of 7 years.

LARGE OPEN STAKE: For dogs over 17-1/2 inches at the withers that have not achieved the title of LCC.

LARGE EXCELLENT STAKE: For dogs over 17-1/2 inches at the withers that have achieved the title of LCC.

LARGE VETERAN STAKE: For dogs over 17-1/2 inches at the withers that are over the age of 7 years.

SIGHTHOUND MIX OPEN STAKE: For dogs with sighthound breed in its background that have not achieved the title of LCC.

SIGHTHOUND MIX EXCELLENT STAKE: For dogs with sighthound breed in its background that have achieved the title of LCC.

SIGHTHOUND MIX VETERAN STAKE: For dogs with sighthound breed in its background that are over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

Conditions of Entry:

All entries must be one year or older on the day of the trial

Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more

Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.

Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Singles Stake ● Hounds not present at the time of roll call will be scratched
All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Region 6 Invitational Perpetual Trophies

All perpetual trophies must be returned to the 2025 Region 6 Invitational.

Irish Wolfhound — **The Brynmair Trophy**

Eve's descendants include five #1 RRs: Phoebe, Maggie Mae, Ida, Wanda and Nitro, as well as seven Lifetime Top Twenty RRs: Ida, Star, Zappa, Troi, Tango, Wanda and Nitro. Eve's love for coursing was distinguished by her signature chortle before the Tally-Ho and her passion to shred the bunnies...two traits that seem to be inherited by her offspring!

Saluki — **The Saluki Trophy**

Donated by Tom Cigolle Jr in loving memory of BIT Montebello Sherom's Fuhais LCM6. Fuhais' wish was to make sure that the Salukis of today and tomorrow are always honored and remembered. Her passion for the chase is the legacy she leaves to us all.

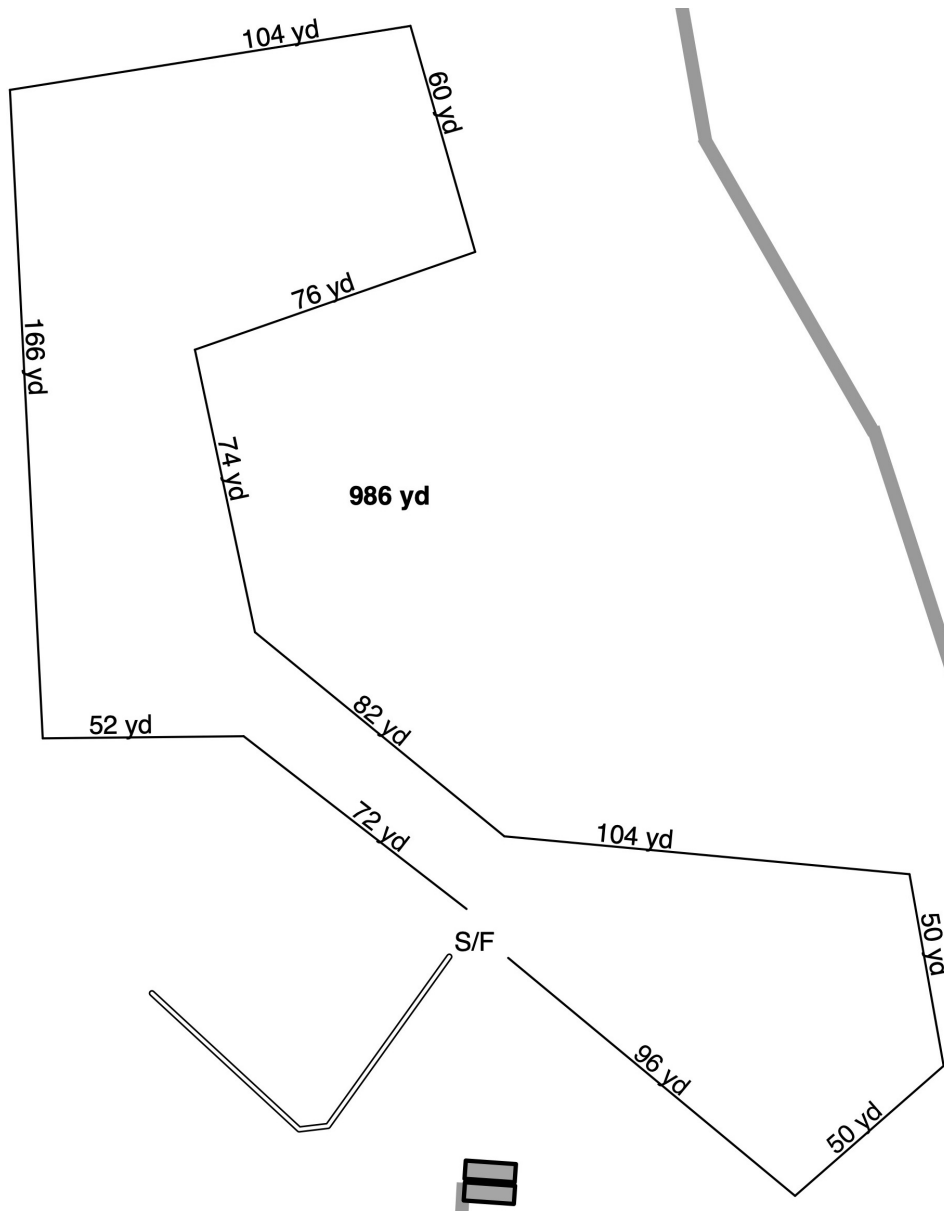
Whippet — **The Bevis Trophy**
