## ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etnas, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, Whippets and Provisional breeds may be entered in the Regular Stakes.

Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All non-sighthound breeds and mixed breeds are eligible for the LCI Stake.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record, that has met the certification process.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Saluki, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

## **Best in Field Will Be Offered Both Days**

**CONDITIONS OF ENTRY:** All hounds must be one year of age on the day of the trial. Bitches in season and lame hounds will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are eligible to enter in the Singles Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice in trios or braces (if possible), except in the Singles Stake unless excused, dismissed or disqualified. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.

**EQUIPMENT:** Type of lure machine: GAS-powered continuous-loop system. • Type of lures: highly-visible white plastic strips • Back-up equipment will be available.

Lure Chasing Instinct Program: All dogs entered must have a registration number via one of the following: A. AKC/CKC Registration as one of the recognized breeds. B. CKC (CCN)/AKC Canine Partners, which is for mixed breed dogs and dogs ineligible for AKC/CKC registration. C. Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events. D. Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition. E. United Kennel Club (UKC) registration as one of the recognized breeds. F. If the dog has none of the above registrations, ASFA will provide a unique and permanent entry number for a one-time \$10 charge. Page 8 is the Lure Chasing Instinct Entry Form for those dogs who have registration numbers from either the AKC or UKC. Page 9 is the Request for Unique Entry Number Form for dogs those who do not have a registration number from either the AKC or UKC. 1. The owner must complete an ASFA Request for Unique Entry Number (page 9). 2. The Trial Secretary will submit a copy of the form with the records. 3. The owner will retain a copy as proof of request and payment until permanent number is provided.

**Small Open:** dogs 17.5" or less at the withers and/or brachycephalic (flat-faced) dogs who have not achieved the title of LCC.

**Small Excellent:** dogs 17.5" or less at the withers and/or brachycephalic who have achieved LCC.

**Small Veteran:** for dogs 17.5" or less at the withers and/or brachycephalic over the age of 7 years.

**Large Open:** dogs over 17.5" at the withers who have not achieved the title of LCC.

**Large Excellent:** dogs over 17.5" at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17.5" at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background that has not achieved the title of LCC.

**Sighthound Mix Excellent:** for dogs with a sighthound breed in its background that has achieved the title of LCC.

**Sighthound Mix Veteran:** for dogs with a sighthound breed in its background over the age of 7 years.

When running as a Stake within a regular ASFA trial, small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other Stakes will run the full ASFA laid out course length.

**PRACTICE** Saturday only. \$10 per run. Pre-register for practice before entries close Thursday, Sept. 19. No exceptions!

**CERTIFICATIONS :** Please ensure that your hound is running a strong course alone prior to attempting a certification. Please also arrange a hound to certify with ahead of time.

Both practices and certifications are offered on Saturday at the end of the trial (following ribbons and awards. See the FTS if unsure.
