

## Directions to Friendship Park

**From US-22 West** - Take Hopedale Rt. 151 exit. Head South West on West Main St./Mill St. Take a slight left onto Ohio 151 for 7.5 miles. Turn left onto Bloomingdale County Rd. 23/Smithfield Rd. and continue for 0.4 mile. Take a sharp right turn onto Friendship Park Rd. and continue for 0.4 mile to the end of the street where it turns left up the hill.

**From US-22 East** - Follow US-22 to Steubenville, OH crossing the Veterans Memorial Bridge (over the Ohio River) stay to the right on the bridge and follow signs to State Rt. 7 South. Follow State Rt. 7 South approximately 5.7 miles to the New Alexandria/Smithfield exit for State Rt. 151. Turn right off the exit and follow State Rt. 151 for approximately 10.5 miles. Turn right onto County Road 23/Smithfield Rd. and go approximately 0.4 mile. Take a sharp right hand turn onto Friendship Park Road (past covered bridge) and follow road 0.4 mile where the road make a left up the hill.

**From I-70 East/West** - Take Exit 225 for State Rt. 7N. Follow State Rt. 7N to the New Alexandria/Smithfield State Rt. 151 Exit. Turn left off the exit to follow State Rt. 151 toward New Alexandria and follow State Rt. 151 for approximately 10.5 miles. Turn right onto County Road 23/Smithfield Rd. and go approximately 0.4 mile. Take a sharp right hand turn onto Friendship Park Road (past covered bridge) and follow road 0.4 mile where the road make a left up the hill.

### Care of the Grounds

Kindly enter the field at the designated area only. Parking areas will be clearly marked. Please clean up after your hounds. Smokers please do not leave cigarette butts on the ground. There will be a \$15 fine levied on all smokers leaving cigarette butts on the grounds or people caught not cleaning up after their dogs!!

### PLEASE NOTE:

**Please bring your own shade and water.**

**There will be portable toilets available – DO NOT put poop bags in the toilet!!!**

- Limited space is available adjacent to the conformation show grounds. Must be reserved with the kennel club.
- NO CONCESSIONS AT THE FIELD.
- Bring your own water and shade
- All owners must keep their hound under control at all times. There will be a \$5 fine assessed for any loose hound on the field not taking part in the course in progress.

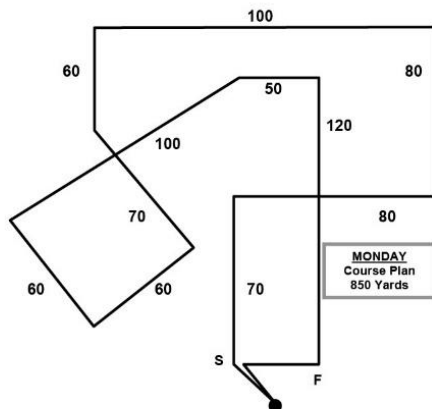

### **Regular Stakes:**

**Open Stake:** Open to all eligible Pharaoh Hounds, excluding ASFA Field Champions of record. First time entrants must include a certification form and copy of registration.

**FIELD CHAMPION STAKE:** Open to Pharaoh Hounds that are ASFA Field Champions

**VETERAN STAKE:** Open to Pharaoh Hounds whose age is at least six years.

**SINGLE STAKE:** Any eligible Pharaoh Hound including those disqualified to run in other stakes. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

### **NON-REGULAR STAKES\*\*\***

**BREEDER STAKE:** For two Pharaoh Hounds, designated at time of entry, bred by the same individual.

**KENNEL STAKE:** For two Pharaoh Hounds, designated at time of entry, owned and kenneled by the same individual.

**BENCH STAKE:** A Pharaoh Hound that is entered in one of the regular stakes and is an AKC, CKC, UKC or ASFA-approved International show champion of record. A copy of the hound's championship certificate must accompany each entry.

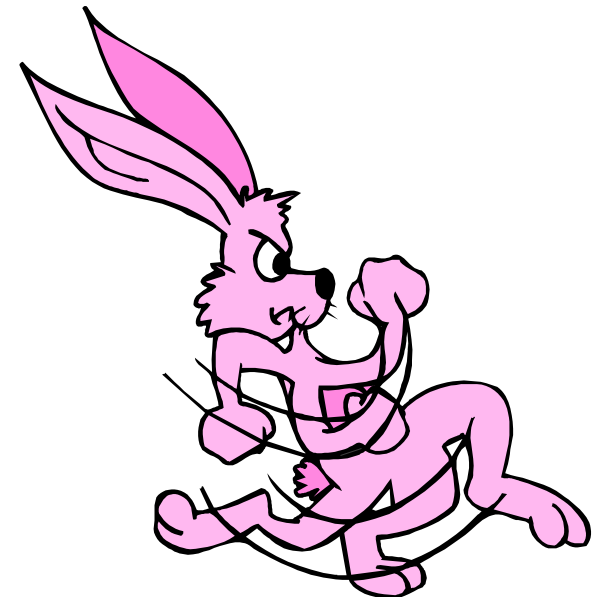

## **GENERAL INFORMATION**

1. All entries must be one year of age or older on the day of the trial.
2. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
3. Bitches in season, lame hounds and hounds will be excused at roll call, Hounds with breed disqualifications will also be excused, unless entered in Singles Stake.
4. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in Singles
5. Hounds not present at the time of roll call will be scratched.
6. Hound certification runs will not be offered.
7. Battery powered continuous loop machines will be used. Lures will consist of white plastic bags. Backup equipment will be available.
8. The course will be reversed for the finals and again for the BOB run-offs.
9. The Field Committee reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.
- 10. Please bring you own shade and water.**
11. No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Chairman.
12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
