

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes.

Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

LURE CHASING INSTINCT (LCI) STAKE

- **A**. AKC/CKC Registration as one of the recognized breeds.
- **B.** CKC (CCN)/AKC Canine Partners, which is for mixed-breed dogs and dogs ineligible for AKC/CKC registration.
- C. Purebred Alternative Listing (PAL) program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- **D**. Foundation Stock Service® (FSS), which is for recorded breeds on the road to full AKC recognition.
- E. United Kennel Club (UKC) registration as one of the recognized breeds.
- **F**. Dogs without a recognized registry number may obtain a unique and permanent ASFA ID number for a one-time \$10 registration fee at the time of entry (entry form below). The Trial Secretary will submit a copy of the form with the records. The owner will retain a copy as proof of request and payment until a permanent number is provided.
